BULK WATER PRICES IN SOUTH EAST QUEENSLAND 2015-2018 SUBMISSION TO THE QUEENSLAND COMPETITION AUTHORITY

The Moreton Bay Regional has made a submission to the Queensland Competition Authority in regards to its review of SEQWater Bulk Water Prices for the period 2015 to 2018. Please find attached a copy of the Council report and associated resolutions for your information.

For the reasons set out in the attached report, Council wishes to make representations to you that the State Government should not proceed with the proposal to recoup the "price path debt" created by the current bulk water prices path as this will lead to higher water prices. However, if the decision is made to proceed with this proposal, then the State Government should ensure that each local government area repay the "price path debt" as allocated to that area, thus continuing the unequal bulk water price until this debt has been redeemed.

The Council also submits that the Redland, Sunshine Coast and Noosa local government areas' price paths should not be continued for a further two years as this would continue the inequity of bulk water prices.

Further the Council submits that the restructure of the bulk water entities from 5 to 1 and the resultant efficiency gains should translate to lower bulk water prices and those operational efficiencies should continue to be driven to achieve lower bulk water prices.

Executive Summary

The Treasurer and Minister for Trade with the Queensland State Government has requested the Queensland Competition Authority (QCA) to conduct a review of SEQWater Bulk Water Prices 2015-2018 and the conduct of this review was advertised in the Courier Mail on Saturday on Saturday, 1 May 2014.

OFFICER'S RECOMMENDATION

That the Council submit to the Queensland Competition Authority that:

REPORT DETAIL

Background

The last review conducted by the QCA for the SEQ Bulk Water prices was for the 2012/13 period with the QCA's final report being published on its web site on 16 July 2012. This review showed that SEQ bulk water prices at that time (eg average of \$2,015/ML) were only recovering approximately 59% of the efficient and effective cost of the provision of bulk water to SEQ. This review stated that the QCA considered the price of \$3,431/ML to be sufficient to fully recover the cost of delivering bulk water to the region.

2. Explanation of Item

The current bulk water price path (see table below) indicates that SEQ Local Government areas are on an unequal price path to a final price of \$3,217/ML by the 2017/18 financial year. Given the outcome of the 2012 review this price is still only recovering approximately 94% of the full cost of delivering bulk water to SEQ.

This means that since implementation, the SEQ water grid has not been recovering the full price for the delivery of bulk water to the region. As a result, the region is accumulating what is called a "price path debt". In the Treasurer's referral to the QCA he has requested that this "price path debt" be recouped from future water prices by the year 2027/28. It is believed that it is inequitable for this debt to be recovered from all local government areas equally, as some local government areas followed a much slower price path than others, thus incurring a far greater "price path debt" than those whose price path was higher earlier in the path.

It is therefore submitted that this debt, should be -

 written off by the State Government and not recovered from future water prices as this does not match the cost of the water to its consumption and it is inequitable to charge costs incurred today on the users of the future.

However, if the decision is made to proceed with this proposal, then -

all local government areas should "repay" the "price path debt' as allocated to each local government area in the same proportion as they have been contributing to the recovery of bulk water costs since the beginning of the price path, ie the slower and longer the path to a common price, the more the local government area is contributing to the price path debt, the more it should repay that debt.

If the latter option is adopted, then this should lead to higher bulk water prices for the period stipulated by the Treasurer (ie. up to the year 2027) for those local government areas in order to recoup their portion of the "price path debt".

Also, in the Minister's referral notice he refers to extending the current pricing allowance given to Redland, Sunshine Coast and Noosa local government areas by two years. This is not equitable to all other water consumers in south-east Queensland and is not supported. If this inequity continues and is extended then these local government areas (as previously stated) should contribute more to the repayment of the "price path debt" as they would be continuing to contribute to the size of this debt.

Since the previous review it is noted that the number of entities involved in the delivery of bulk water to SEQ has decreased (from 5 to 1). It is unknown what affect this restructure should have on prices but this should play some part in reducing the cost of bulk water and thus the price to consumers.
