Queensland Rail's Reference Train Service DAAU—Stakeholder notice

The Queensland Competition Authority received a draft amending access undertaking (DAAU) from Queensland Rail on 23 September 2019, seeking to amend characteristics of the Reference Train Service in Schedule D of its 2016 access undertaking.

Statutory requirements

Section 143(3) of the QCA Act provides that the QCA may only approve a DAAU if (among other things) it has published the DAAU, invited submissions on it and considered any submissions received within the time provided.

We have published Queensland Rail's Reference Train Service DAAU on our website (www.qca.org.au) and invite submissions from interested parties. The closing date for submissions is **22 October 2019**.

Time periods

In accordance with section 147A(2) of the QCA Act, the QCA must use its best endeavours to decide whether to approve, or refuse to approve, a DAAU within six months from the day that is two weeks from the day the undertaking was given to the authority.

The six-month period does not include any of the following periods:

- a day in the period given by the QCA for making submission in relation to a DAAU or a related document
- day(s) agreed to, by the owner or operator of the service or the responsible person, as not being included in the six-month period.

The six-month period commences on 7 October 2019 and is scheduled to end on 22 April 2020. However, the end date may be extended to account for any future periods of time that are excluded from the statutory timeframe in accordance with section 147A of the QCA Act, including any further consultation periods.

An updated notice of time periods will be issued detailing any changes to the stated timeframe for assessing Queensland Rail's Reference Train Service DAAU.

Submissions

Closing date for submissions: 22 October 2019

Public involvement is an important element of the decision-making processes of the Queensland Competition Authority (QCA). Therefore submissions are invited from interested parties concerning its assessment of Queensland Rail's Reference Train Service DAAU. The QCA will take account of all submissions received within the stated timeframes.

Confidentiality

In the interests of transparency and to promote informed discussion and consultation, the QCA intends to make all submissions publicly available. However, if a person making a submission believes that information in the submission is confidential, that person should claim confidentiality in respect of the document (or the relevant part of the document) at the time the submission is given to the QCA and state the basis for the confidentiality claim.

The assessment of confidentiality claims will be made by the QCA in accordance with the *Queensland Competition Authority Act 1997*, including an assessment of whether disclosure of the information would damage the person's commercial activities and considerations of the public interest.

Claims for confidentiality should be clearly noted on the front page of the submission. The relevant sections of the submission should also be marked as confidential, so that the remainder of the document can be made publicly available. It would also be appreciated if two versions of the submission (i.e. a complete version and another excising confidential information) could be provided.

A confidentiality claim template is available on request. We encourage stakeholders to use this template when making confidentiality claims. The confidentiality claim template provides guidance on the type of information that would assist our assessment of claims for confidentiality.
