**Aurizon Network – UT5 Draft Amending Access Undertaking**

I refer to the draft amending access undertaking submitted by Aurizon Network Pty Ltd (**Aurizon Network**) to the Queensland Competition Authority (**QCA**) for approval on 3 May 2019.

Adani Mining Pty Ltd ACN 145 455 205 (**Adani**) is writing this letter in its own capacity.

Adani has not been directly involved in the consultative process by which the draft amending access undertaking was developed though was subsequently consulted by Aurizon Network following their submission on 3 May 2019.

Adani is satisfied that the draft amending access undertaking in the form submitted by Aurizon Network to the QCA on 3 May 2019 contains a significant number of increased and material benefits for access seekers, access holders and their customers, and that those benefits justify the financial outcomes the proposed amendments to Aurizon Network's access undertaking secure for Aurizon Network.

Adani does not by this letter support a draft amending access undertaking that is different to the draft amending access undertaking submitted by Aurizon Network to the QCA on 3 May 2019.

There are some matters contained in the draft amending access undertaking which Adani does not express a view and in respect of which Adani is happy for the QCA to determine in accordance with its discretion. Those matters are contained in the attachment to this letter.

Subject to those matters, Adani support the QCA's approval of the draft amending access undertaking submitted by Aurizon Network on 3 May 2019.

If the QCA makes a final decision to refuse to approve the draft amending access undertaking or does not make a final decision to approve the draft amending access undertaking by 3 January 2020, then Adani may make further submissions to the QCA including in connection with the draft amending access undertaking.

Adani does not express a view in respect of the following matters contained in the draft amending access undertaking and Adani is happy for the QCA to determine the following in accordance with its discretion.

1. the Reference Tariff values in Schedule F (Clauses 7.2, 8.2, 9.2, 10.2 and 11.2);
2. the System Allowable Revenue values in Schedule F (Clauses 7.3, 8.3, 9.3, 10.3 and 11.3);
3. any changes to payloads in Schedule F compared to those shown in the approved UT5 Access Undertaking;
4. GtK Forecasts within Schedule F, to the extent that they differ to those contained in the approved UT5 Access Undertaking; and
5. The values shown in Schedule K.
